Right to Alteration / Modifications:

Payment:

- (i) All demand drafts/Cheques be made in the name of institute (according to course) given in the prospectus (ii) Any other certification will be subjected to payment of fees & charges in full (iii) Any Govt. taxes or levies will be extra as applicable.
